



## Herman VFC Raffle

### Rules Pertaining to the Raffle

---

1. Winners need not be present.
2. You must be at least 21 years old to attend the raffle, unless you are a fireman/woman working the raffle. You must be at least 18 years of age to buy or sell raffle tickets.
3. No tickets will be sold or taken **after 9:00 p.m.** on the night of the raffle.
4. If tickets are not here by 9:00 p.m., the night of the raffle, **the seller will be responsible for rewriting those tickets.** The **“old stubs”** as well as the **“WHOLE new ticket: TOP and BOTTOM, filled out”, AND RETURNED**, with the money, needs to be returned back to the fire company **A.S.A.P.**
5. If tickets are mailed, they must be received the day of the raffle. Please mail your tickets at least “5” working days before the raffle.
6. **Please put your account number on the ticket stub, where it is marked “Sold by” for proper credit to your account. No need to recopy your name there, just the number.**
7. **All tickets** must be **returned** sold or **unsold** by the night of the raffle.
8. **No member** of the Fire Company will pull the winning ticket on raffle night.
9. The bartender has **“the right”** to card anyone. **No pitchers of beer** will be permitted outside of the firehall building.
10. All ticket stubs must have the buyer’s **full name, (not just an account number or nickname), phone number and the seller’s account number on it.**
11. Doors upstairs will be open at 5:30 p.m. the night of the raffle. The doors will be closed at 10 p.m. following the drawing.
12. No person or persons are permitted downstairs the night of the raffle, unless they are on the raffle committee.
13. The seller of the first prize winning ticket will receive \$100.00; the second prize ticket seller will receive \$50.00.
14. The top “50” sellers, for the year, will have their names put in for a \$500.00 drawing the following January.

15. The top “50” sellers, for the year, will have their names put in for a \$500.00 drawing the following January.
16. An additional charge of \$20.00 will be initiated for any checks returned for **Non-Sufficient Funds.**
17. Each seller’s account will accrued \$1.00 credit for every 3 books/15 tickets that he/she has sold. This amount can accrued from year to year, or if you wish, you can redeem your books. You may redeem your book two days out of the month, **raffle night or the second Monday of each month.** If you wish to redeem them the second Monday of the month, you must call **before noon** that Monday; it will be mailed out to you the very next day.
  - a) When you redeem your books, the amount can be redeemed for cash, gift certificates (restaurants), smoke detectors or CO2 detectors.
  - b) **If you receive more than \$599.00** in one given year (**January to December**), on your account number, you will be required to fill out a W-9 Tax form, and also supply your S.S. #, so that a 1099 Tax form can be filled out. You will than receive a W-2G Tax form at the end of the year from the fire company.
  - c) The money that will be tabulated will include redeemed books, money from being a “Top 10 Seller”, plus if you sell one of the winning tickets, be it first or second place.
18. Each seller’s account will accrued \$1.00 credit for every 3 books/15 tickets that he/she has sold. This amount can accrued from year to year, or if you wish, you can redeem your In the event that a blank ticket stub is drawn raffle night:
  - a) The number will be published;
  - b) All stubs will be held for one year;
  - c) If the winning ticket **is not claimed** at the end of the year, the Pennsylvania Small Games of Chance law will be adhered to!
18. In the event that more than one ticket stub is drawn at the same time, the tickets (**names and numbers not read**), will be put back into the barrel and **"one ticket will be drawn."** **The Fire Company Representative will not accept more than one ticket stub at a time. One stub per First Prize and one stub per Second Prize.**
